I installed a new power harness for the Sierra wireless modem on the 185 and calibrated the 380 which includes a roll Cal a steering angle sensor calibration as well as a slew test and dead zone test . I mentioned I will be back to clean up cords on the 185 which you will not be billed for next time I'm up there, but 2 hours went to the 185 and 2 hours on the 380 plus the cost of the power harness.
